Certificate of Composition

I Andrew Ferguson Esquire Commissioner Appointed, by His Excellency The Lord Lieutenant, and sworn under and by virtue of an Act made in the 2^d and 3^d of the Reign of King William the 4th and 5th Intituled: An Act to amend Three Acts passed in the Seventh and Eighth years of the Reign of his late Majesty King George the 3^d: Providing for the Establishing of Compositions for Tithes in Ireland, and to make such Compositions Permanent. To ascertain and fix a true and just Composition for all Tithes, arising, growing, yielded or payable within the Parish of Mohill in the Counties of Leitrim and Longford;

Do hereby Certify that the true and just Amount of Compositions for all Tithes whatever within the said Parish is Six Hundred and fifty four pounds, Ten Shillings and 1² pence Sterling, Of which Sum of Six Hundred and fifty four pounds Ten Shillings and 1² pence Sterling, Two Hundred and eighteen pounds, Three Shillings and four ³/₄ pence Sterling is due and payable to Sir Morgan George Cropper Bart. Owner of the Rectorial or Lay Impropriate Tithes of the said Parish of Mohill, and Four Hundred and thirty six pounds Six Shillings and nine ³/₄ pence Sterling is due and payable to The Rev^d Arthur Hyde as Vicar of the said Parish of Mohill.

And further Certify that the Average Price of Oats, being the Corn principally grown in such County for the Period of seven years ending on the first day of November 1830, is Twelve Shillings and Eleven pence half penny per Barrell,
