Memorandum.

Mochill 15 July 1834

Pursuant to the Notice bearing date the 21st June 1834, I have this day proceeded, to the adjudication of such Objections as might be made against my Estimate and Valuation of the Parish of Mochill in the Diocese of Ardaugh, and having by Proclamation. Proceeded to Call over the Inhabitants, and Land holders, of the different Townlands Subject to Tithes, within the said Parish, vizt.

- 1st Call (at 12 O'clock P.M.) No appearance
2nd Call (at 2 past 12 O'clock P.M.) No appearance
3rd Call (at 1 O'clock P.M.) No appearance.

Consequently the Court is hereby dissolved and the said Estimate, and Valuation, Confirmed.
