

We the undersigned Commissioners under the Tithe Composition Acts for the Parish of Aldmole in the County of Tipperary do hereby certify that by our valuation and Survey thereof we find the same to contain Two thousand nine hundred and fifty three acres and nine perches Irish plantation measure in which is included that part of said parish called the Retrenched lands of Aldmole containing Six hundred and Seventy four acres and two perches Irish plantation measure. We award that that part of said retrenched lands marked First quality containing ten acres and worth fifty five Shillings per acre shall pay the sum of two Shillings and eleven pence half penny per acre and so in proportion for roods and perches as a Composition for all the tithes thereof. We award that three hundred and thirty one acres and six perches of said retrenched lands marked second quality and worth forty Shillings per acre shall pay the sum of one Shilling and one penny half penny per acre and so in proportion for roods and perches as a Composition for all the tithes thereof and we award that that part of said retrenched lands marked third quality containing Two hundred and thirty nine acres two roods and twenty six perches and worth twenty Shillings per acre shall pay the sum of one Shilling and one penny half penny per acre and so in proportion for roods and perches as a Composition for all the tithes thereof and we award that that part of said retrenched lands marked fourth quality containing ninety three acres and two roods and worth ten Shillings per acre shall pay the sum of six pence per acre and so in proportion for roods and perches as a Composition for all the tithes thereof - We award that all the remaining part of said Parish shall pay the following sums as a Composition for all the tithes thereof, that is to say those lands marked first quality containing four hundred and forty seven acres and worth fifty five Shillings per acre shall pay the sum of three Shillings and four pence three farthings per acre and so in proportion for roods and perches as a composition for all the tithes thereof We award that those lands marked second quality containing one thousand one hundred and Seventy Seven acres two roods and five perches and worth forty Shillings per acre shall pay the sum of two Shillings and five pence per acre and so in proportion for roods and perches as a Composition for all the tithes thereof. We award that six hundred and twenty acres and sixteen perches marked third quality and worth twenty Shillings per acre shall pay the sum of one Shilling and four pence farthing per acre and so in proportion for roods and perches as a Composition for all the tithes thereof - and we award that thirty five acres and twenty perches marked fourth quality and worth ten Shillings per acre shall pay the sum seven pence per acre and so in proportion for roods and perches as a composition for all the tithes thereof and finally we find that the above mentioned sums payable out of the above quantity of lands make the sum of Three hundred and twelve pounds nine Shillings and two pence half penny Sterling being the sum agreed on between the different parties as a composition for all the tithes great and small of said parish all the Surveys are made in Irish plantation measure roods not included, and all sums of money mentioned are in British Currency - Given under our hands and seals the this second day of June in the year of our Lord one thousand eight hundred and twenty Seven
