OBSERVATIONS

To all to whom these presents shall come I the Reverend Henry Maxwell Ecclesiastical Incumbent and Rector of the Parish of Ballymacormick in the County of Longford send Greeting -

WHEREAS William Fulke Greville of Marine Parade Dover in the County of Kent in that part of the United Kingdom of Great Britain and Ireland called Great Britain Esquire has truly served me with a Notice in Writing in the words and figures following -

SIR,

Take Notice that in pursuance of an Act passed in the second and third years of His present Majesty's reign entitled "An Act to amend three Acts passed respectively "in the Fourth, Fifth and in the Seventh and Eighth years of the reign of his late Majesty King "George the Fourth providing for the establishing of compositions for Tithes in Ireland "and to make such compositions permanent". And of an act passed in the Third and Fourth years of the same reign entitled "An Act for the relief of the owners of Tithes in Ireland "and for the amendment of an Act passed in the last session of Parliament intituled an Act "to amend three acts passed respectively in the Fourth Fifth and in the seventh and Eighth "years of the reign of his late Majesty King George the Fourth providing for the establishing "of compositions for Tithes in Ireland and to make such compositions permanent." I, William Fulke Greville of Marine Parade Dover in the County of Kent in that part of the United Kingdom of Great Britain and Ireland called Great Britain Esquire do hereby signify my desire and intention to agree for and undertake the future payment of the composition and of all sums which shall become due and payable on account of the composition which under the laws in force in Ireland for the composition of Tithes is now fixed and established as the composition for all tithes for and in respect of the lands of Ballyminion otherwise Salsbury Plains otherwise Salisbury Plains, Cloontern otherwise Clontern, Clooneena, Cloonturk otherwise Clonturk, Cartronageera otherwise Cartrongerah and Churchland a sub-denomination thereof, Farnyhoogan, Gorowagh otherwise Garvagh and Aughafad a subdenomination thereof, Knockanboy, Mullaghmoreneen otherwise Mulloghavorneen and Stonepark otherwise Clougher, which said lands are meared and bounded on the North by the lands of Mullagh, on the East by the lands of Longford, certain glebe lands, the lands of Farnagh and Lisfudd, on the south by the said lands of Lisduff, an undivided red bog, the lands of Ballymichael, Dunbeggan, and Gragh, and on the West by the said lands of Gragh, an undivided red bog and said lands of Mullagh - all which lands are situate in the Manor and Parish of Ballymacormick
