*Suclain* Incumbent of the Parish of *Leashell Diocese of Ardagh*  
in the County of Longford send Greeting, WHEREAS *John P. Robinson Esq of Lisfalsick*  
in the County of *Longford* has truly served me with a Notice in Writing, in  
the Words and Figures following.

SIR,—You are hereby required to take Notice, that in pursuance of an Act passed in the  
second and third year of his present Majesty, entitled, an Act to amend three Acts passed respec-  
tively in the fourth, fifth, and in the seventh and eighth years of the Reign of his late Majesty,  
King George the Fourth, providing for establishing of COMPOSITION of TITHES in Ireland,  
and to make such Compositions permanent, I *John P. Robinson as Agent to and on*  
*behalf of The Lord Viscount Lorton* in the County of *Rockingham*  
~~have~~ *who is seized in fee simple* of All That and Those,

*The lands of Ballybeg, Ballymore, Terragawna*  
*Serryglass and Derrycaugh*

situate in the Parish of *Leashell* Barony of *Rathclive* and  
County of *Longford* or otherwise entitled, according to the Provisions of said  
Act, to agree for and undertake the Payment of the Composition for Tithes lawfully payable for  
and in respect of such Lands, do hereby signify to you my desire to agree for and undertake the  
Payment of such Composition as aforesaid, for and in respect of the said Lands, and I hereby re-  
quire you to grant me a Certificate in Writing, conformable to the Provisions of said Act, declaring  
me entitled to the benefit of this Notice, and to perform the other matters on your part required  
by the said Act to be done.
