commissioners duly appointed and sworn under  
and by virtue of an act made in the fourth  
year of the reign of King George the fourth entitled  
an act to provide for the Establishment of a commission  
of Tithe in Ireland for a limited time, to ascertain  
and fix a true and just composition for all Tithes  
arising growing yielded or payable within the  
Parish of Comeston in the County of Meath  
do certify that the true and just amount of  
composition for all Tithes within the said Parish  
is Eighty Pounds by the Year but such sum of  
Eighty Pounds. Fifty five Pounds are due and  
payable to the Revd John Smyth as composition  
for the Tithe claimed by him as Rector of  
said Parish and the remainder Part is due to the  
Revd George Brabazon the Vicar as owner of the  
Parishal Tithes of the said Parish
