Montrose, Lord Chamberlain; his son, the Marquis of
Graham, Vice Chamberlain; and his Grace the Duke of
Dorset, Master of the Horse; have retired from their

His Majesty has been pleased to appoint his Royal
Highness the Duke of Clarence to be Lord High Admiral
—and we have the satisfaction of being able to add, that
it is understood the whole of the present Board of Admi-
rality (with the exception of Viscount Melville, who had
resigned three days since) will continue their services.
We alluded yesterday to the rumour of his Grace the
Duke of Wellington having resigned his Office as Com-
mander-in-Chief. The rumour is confirmed. His Grace
retires, not only from the Horse-Guards, but from the
Ordnance.

As a proof of the determination of the King to support
the Minister to whom he has entrusted the formation
of a Government, against any factious or personal oppo-
sition, his Majesty, since the resignation of Lord Mel-
ville, has determined to appoint his Royal Highness the
Duke of Clarence, Lord High Admiral of England, with
a Council, for the administration of the affairs of the
Navy. His Royal Highness will be placed in regard
to the navy, in the same position in which the Duke of
York stood with respect to the Army. As in the case of
the late Commander-in-Chief, he will not have a seat in
the Cabinet.—*Globe.*

The Chancellor, Mr. Canning, and Lord Bexley, had
audiences yesterday of the King, at his Palace in St.
James's.
Although the Chancellor sent in his resignation to his
Majesty on Thursday afternoon, the noble Earl, it is ex-
pected, will retain the Seals for a month longer, till he
has given judgment on the cases that have been heard
before him.

The desire avowed by Mr. Canning had always been to
form a Government on the principles of Lord Liverpool's
administration; that is to say, on the avowed principle of
neutrality with respect to the Catholic Question. Whether
the same course would now be deemed desirable, we do
not profess to know. It must depend on Mr. Canning's
judgment as to the temper and general interest of the
country.—*Globe.*
