ment of the Composition for Tithes lawfully payable for and
in respect of the said lands. Do hereby signify to you my desire, to agree
for and undertake, the payment of such Composition as aforesaid
for and in respect of the said lands and I hereby require you to grant
me a Certificate in writing conformable to the provisions of the
said Act declaring me entitled to the benefit of this notice
and to perform the other matters on your part required
by the said Act to be done,
