

I do hereby certify that in pursuance of an Act passed in the 2nd and 3rd years of the Reign of His present Majesty
"An Act to amend three Acts passed respectively in the 4th, 5th and
"in the 7th and 8th years of the Reign of his late Majesty King George
"the 4th providing for the establishing of Compositions for Tithes in Ireland
"and to make such Compositions permanent" And of another
Act passed in the 3rd and 4th years of the same Reign, entitled an
Act for the relief of the Owners of Tithes in Ireland, and for the
amendment of an Act passed in the last Session of Parliament
entitled "An Act to amend three Acts passed respectively in the
4th, 5th and in the 7th and 8th years of the Reign of his late
Majesty King George the 4th providing for the establishing
of Compositions for Tithes in Ireland, and to make such
Compositions permanent", a Notice in Writing has been served
upon me as Ecclesiastical Incumbent of the Parish of Killee in
the County of Longford aforesaid, by or on behalf of the Right
Hon^{ble} Thomas Earl of Longford, which said Notice is as
follows, that is to say, — "Take notice that in pursuance of an
act passed in the 2nd and 3rd years of His present Majesty entitled
"An act to amend three acts passed respectively in the 4th, 5th
and in the 7th and 8th years of the Reign of his late Majesty
King George the 4th providing for the Establishing of Compositions
for Tithes in Ireland and to make such Compositions permanent
and of an act passed in the 3rd and 4th years of the same reign
entitled "An act for the relief of the Owners of Tithes in Ireland and
for the amendment of an act passed in the last Session of Parliament
entitled "An act to amend three acts passed respectively in the
4th and 5th and in the 7th and 8th years of the Reign of His late
Majesty King George the 4th providing for the establishing of
Compositions for Tithes in Ireland and to make such Compositions

permanent" I do hereby signify my desire and intention to
agree for and undertake the future payment of the Compositions, and
of all Sums which shall become due and payable on account of
the Compositions, which under the laws in force in Ireland for the
Compositions of Tithes is now fixed and established as the Compositions
for all Tithes for and in respect of the lands of Siltgraw, Kilmacraugh
and Brundow situated in the Parish of Killee and County of
Longford, which said Lands and premises are bounded on the North by Boker, on the East
by Corlea, Trelawne, Clonca and Kiltinan — on the South by Corrigliff and on the West
by Kiltinny and Drumwoe
And I do hereby require you in pursuance of the provisions of
the said acts, to grant me a Certificate under your hand and
Seal reciting this Notice and declaring me entitled to the
