

We whose Names are hereunto subscribed being the Commissioners duly appointed under the Act of the fourth of King George the fourth, for ascertaining the amount of Composition for Tithes in the Parish of Killeken in the Diocese of Elphin, belonging to the Archdeacon of Elphin, and for apportioning such amount on the respective Occupiers on Townlands in said Parish, do certify that the amount of Composition for Tithes being settled by our certificate bearing date the 9<sup>th</sup> of October One Thousand eight hundred and twenty seven, at one Hundred and One Pounds, seven Shillings and Eight pence Sterling, that we have apportioned the said amount of £101. 7. 8 on the respective Occupiers on the Townlands, as detailed in the preceding pages in this Book of our apportionment, and that we have set forth on said apportionment the several districts of the said Parish of Killeken, and also a statement of the several sorts and qualities of the land therein, charging per Acre One Shilling and one penny on the first quality, Eleven pence on the second quality, Nine pence on the third quality, seven pence on the fourth quality, and four pence halfpenny per Acre on the fifth quality of land and lastly we find that the number of Acres in said Parish chargeable for Composition for Tithes, are Two Thousand, six hundred and forty six Acres, two Roods thirteen perches and One half, which is exclusive of Rivers, Roads and Red Bog, and that the sums set forth in this apportionment are payable to the Venerable Archdeacon John O. Oldfield the present Incumbent of the said Parish of Killeken and to his Successors, Rectors of said Parish
