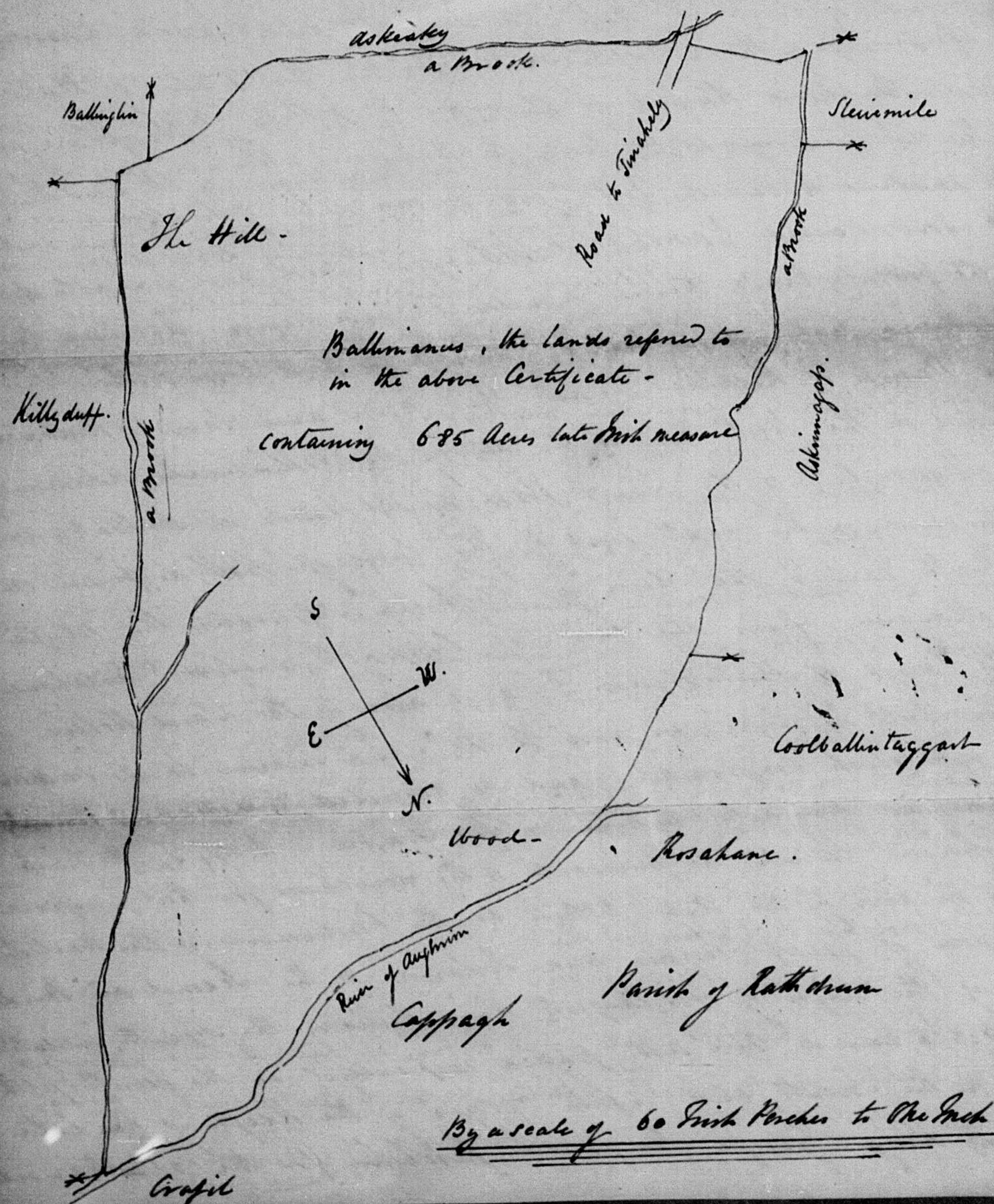

Copies of a Notice served on the Rev^d Ralph Cumine by Daniel Fijhe Esq^r Rosane Feb. 7 1833

I hereby give you Notice as Vicar or Ecclesiastical Authority of the Parish of Kilpiper parts situated in the Barony of Ballinacor and County of Wicklow, that I am desirous pursuant to the provision of the Statute of the 2^d & 3^d of W. the 4th Ch. 119 - to agree for and undertake the future payment of the Tithe Composition (deducting therefrom 15 per Cent for Annum), which is payable for the small or vicarial Tithes out of my Estate of Ballinanus, in the above described Parish of Kilpiper containing 685 Acre Irish Plantation measure or thereabouts, which Estate I hold in fee simple and the boundaries of which are, according to the best information I can obtain as follows - viz - on the N. W. the lands of Coolballintaggart, Askinegapp and Stevemile, on the S. W. the lands of Askinegapp and Ballinanus, on the S. E. the lands of Killyduff & on the N. E. the river of Aughrim separating the Estate of Ballinanus from the lands of Cappagh, Croppil and Rosahane in the Parish of Rathdrum - I have therefore to request that you will furnish me with an Account of the Tithes payable to you out of the said lands, and also with the Certificate required by the 22^d Section of the above recited Act of Parliament
