Michaelmas Quarter Sessions 1889

In the Matter of an Application to vary
the Tithe Rent Charge of the Parish of
Mothel in the County Waterford payable
to the Representatives of the Rev. Daniel
H. Wall and the two Misses Hardy.

WHEREAS it appearing to the Chairman and Justices presiding at the Quarter Sessions of the Peace for the County of Waterford held at Waterford in the said County on the 24th day of September 1889 that Edward Count de Poher de la Poer Lord of le Power and Coroghmore Edward M. Quinn and Miss Mary Anne Quinn being three Land Owners in the Parish of Mothel in the County of Waterford aforesaid each of whom is respectively liable to and charged with the annual payment of the sum of £3 or upwards for Rent Charge in lieu of composition for Tithes within the said parish other than Tithe Rent Charge which became vested in the Commissioners of Church Temporalities in Ireland under or by virtue of the Irish Church Act 1869 or the Acts amending the same, caused a Notice in Writing signed by them to be posted on the principal outer door of the Church of such parish on two successive Sundays since the 1st day of May 1889 that is to say on Sunday the 8th day of September 1889 and on Sunday the 15th day of September 1889 pursuant to the Statute in that case made and provided the last of such Sundays being more than 8 days previous to the day of holding the said Quarter Sessions signifying that it was their intention to make an application to the Justices at said Quarter Sessions to have the average price of Oats for the seven years preceding inquired of and ascertained in order that the Composition in lieu of which said Tithe Rent Charge was payable might be varied and diminished and the said Rent Charge payable in lieu thereof (other than such rent charges as became vested as aforesaid in the Commissioners of Church Temporalities in Ireland) varied and diminished in like proportion for the ensuing seven years and also caused a copy of the said Notice to be duly served on the said Representatives of the Rev. Daniel H. Wall and the two Misses Hardy AND WHEREAS the said Edmond Count de Poher de la Poer Lord of le Power and Coroghmore Edward M. Quinn and Miss Mary Anne Quinn having accordingly and in pursuance of said Notice made an application in writing in the terms of the said Notice to the Justice presiding at the said Quarter Sessions to ascertain the average price of Oats as advertized in the Dublin Gazette during the seven years preceding the said application and the posting of the said Notice and the other preliminaries required by the Statute in such Case having been proved and on hearing Mr. Patrick Joseph Kenny Solicitor for the Applicants and Mr. Ernest J. Thornton Solicitor for the said Representatives of the Rev. Daniel H. Wall and the two Misses Hardy the Justices presiding at said Court of Quarter Sessions with the consent of the said Applicants and of the said Representatives
