

To ALL whom these Presents shall come, I *Francis McGuire*
Lessee of the Rectorial Tithes and Incumbent of the Parish of Shrule
in the County of Longford send Greeting, WHEREAS, *J. R. Robinson Esq. of Lissglassick*
in the County of *Longford* has truly served me with a Notice in Writing, in
the Words and Figures following,

SIR,—You are hereby required to take Notice, that in pursuance of an Act passed in the
second and third year of his present Majesty, entitled, an Act to amend three Acts passed respec-
tively in the fourth, fifth, and in the seventh and eighth years of the Reign of his late Majesty,
King George the Fourth, providing for establishing of COMPOSITION of TITHES in Ireland,
and to make such Compositions permanent, I *John R. Robinson*

of *Lissglassick* in the County of *Longford* as Agent to *on*
behalf of the Countess Dowager of Rose of Hans Hall Warwickshire England who is by virtue of a
Forehold being seized of parts of the Lands of Conker of All That and These.

situate in the Parish of *Shrule* Barony of *Rathcline* and
County of *Longford* or otherwise entitled, according to the Provisions of said
Act, do agree for and undertake the Payment of the Composition for Tithes lawfully payable for
and in respect of such Lands, do hereby signify to you my desire to agree for and undertake the
Payment of such Composition as aforesaid, for and in respect of the said Lands, and I hereby re-
quire you to grant me a Certificate in Writing, conformable to the Provisions of said Act, declaring *he*
Ladyship ~~me~~ entitled to the benefit of this Notice, and to perform the other matters on your part required
by the said Act to be done.

is entitled to the benefit of such Notice, pursuant to the Provisions of the said Act, so far as
relates to the several Lands and Premises in said Notice mentioned, and charged with the Com-
position for Tithes for said Parish, and which Lands are more particularly set forth in the Map
hereunto annexed.
