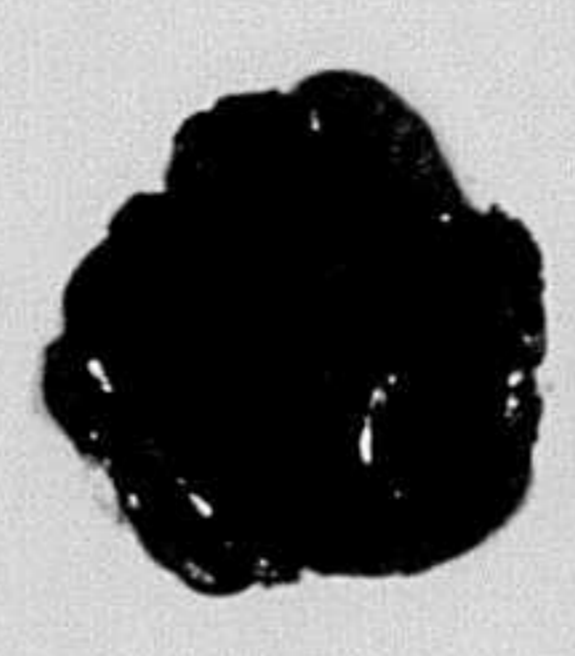


vicarage of Carnew to belong to the Church or Chapel to be erected in the Parish  
of Shilbogh aforesaid (bounded as in said deed mentioned) and to be deemed and Reported to be one entire Parish  
All their Rights as Rectors and Vicars of the said Rectory and Vicarage as by the said deed Registry and Enrollment  
to the said Act July. Siminalur of the said Henry Moore to the said Bishop to be Licensed by him as the precept  
Bishop did July License the said Robert Carpenter accordingly. And the said Robert Carpenter is now perpetual Curate  
of Parliament it is amongst other things enacted that if the Rector or Incumbent of the Parish whereof such perpetual Curate  
Pastor and Bishop of the Diocese or their Successors the Patrons of the Rectory and Vicarage and the Dean and Chapter of the Cathedral  
Writing Endow any such Curate with a competent portion of Glebe or Tithes for the Maintenance of the Curate who should be so  
the payment of a Salary to the said Curate who should be so Endowed such Writing to be registered in the Registry of the  
the said Henry Moore hath proposed to endow the said Robert Carpenter and his Successors perpetual Curates of the said Parish  
Townlands of Ballypally containing Two hundred and Forty five Acres Two Roods and Ten perches Hillbrook containing Seven  
Twenty Four Acres Three Roods and fourteen perches and Glanashuke containing Two hundred and fifty six Acres and Twenty  
to be held and enjoyed by him and his Successors in lieu and discharge of the Salary herebefore paid and payable by the said  
Curate by his Successors and which proposal has been approved of as herein after mentioned. Now this Indenture Witness  
presence for the said Curate and his Successors for his and their Maintenance for ever pursuant to the said Act in lieu of the said Salary  
or Claim of him and against the said Rector and Vicar or his Successors and for and in consideration of the sum of Ten Shillings by him  
and by and with the Consent and Approbation of the said Right Reverend Thomas Lord Bishop of Loughlin and Ferns Patron of said  
Tenor. **Witness** for himself and his Successors Rectors and Vicars aforesaid Granted Bargained Sold and Confirmed and by those Present  
of the said newly erected Parish or Chapel of Shilbogh and his Successors Curates thereof **All That and Chose** the Tithes great  
and Lands of Ballypally Hillbrook Poulbeg and Glanashuke with the appurtenances in the County and Parish aforesaid and the vicar  
and demand whatever both at Law and in Equity of the said Henry Moore and his Successors of or unto the same and every part  
said Robert Carpenter Curate of the said perpetual Curacy or parish of Shilbogh and his Successors perpetual Curates thereof for ever  
perpetual Curacy for ever and with the said hereby granted Promises the same being a competent portion of the said Tithes for the maintenance  
approbation aforesaid Testified as aforesaid Endow the said Robert Carpenter Curate aforesaid and his Successors Curates of the said Parish  
heretofore paid and agreed and directed to be paid by the said Henry Moore as Rector and Vicar of the said Parish of Carnew and of all  
or his Successors by the said Curate or his Successors at any time or times hereafter. **In Witness** whereof the said Henry Moore and Robert  
has hereunto set his Hand and approved Seal and the said Dean and Chapter of the Cathedral of Saint Colman in the said Diocese of
